**6** Automatically transcodes video so it's immediately playable.

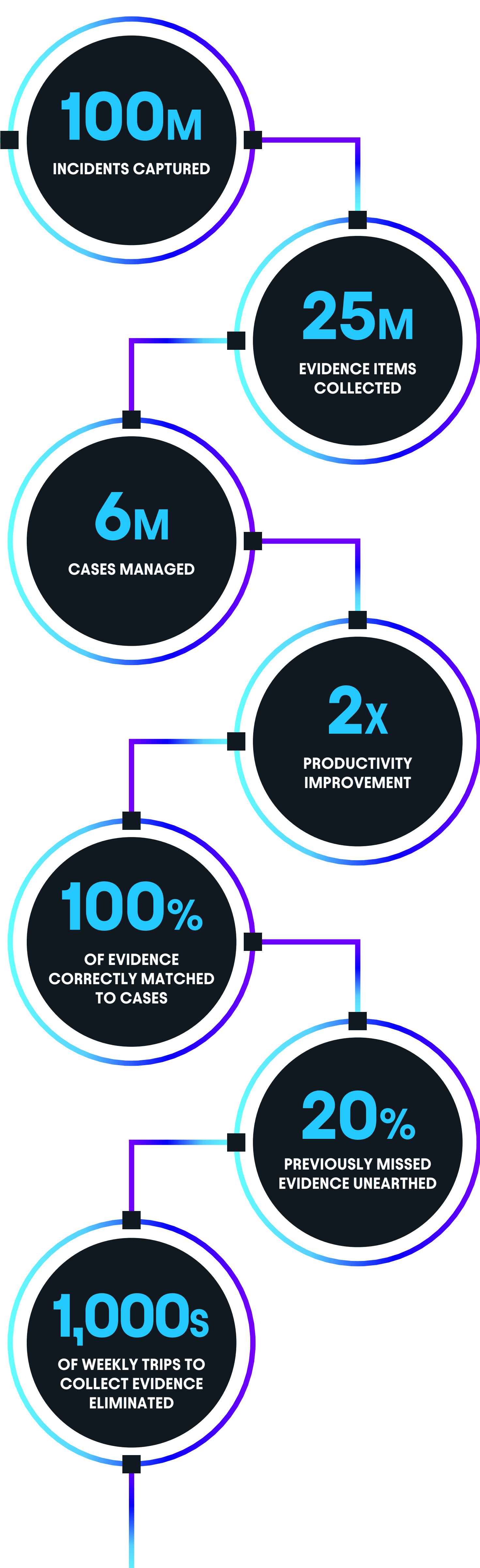
**7** Eliminates long wait times for evidence (e.g. body-worn video, 911 audio recordings).
